1. GENERAL INFORMATION

The Civil Protection in Times of War course curriculum was developed on the basis of the International Security Cluster curriculum to share the experience of the State Emergency Service of Ukraine units in martial law and establish communication with fire and rescue (emergency) services of the European Union and international partners.

The training course was prepared with the participation of the bodies and units of the State Emergency Service of Ukraine, taking into account the practical experience of operation in a special period.

The training course is organized and conducted at the Lviv State University of Life Safety and the training ground in Boryslav of the Main Directorate of the State Emergency Service of Ukraine in Lviv region.

The programme focuses on the organisation and performance professional tasks by civil protection authorities and units in wartime and consists of the following content modules:

I. Organisation of civil protection measures under martial law.

II. Response to emergencies under martial law.

III. Psychological support under martial law.

The training material is taught face-to-face with remote connection of representatives of remote territorial units of SES of Ukraine in the form of demonstrations, discussions, panel discussions and practical training.

The course curriculum "Civil Protection during the War" is intended for representatives of executive authorities and heads of emergency response units of the European Union.

The total training time is 36 hours.

3. INFORMATION CONTENT OF THE COURSE MODULE I Organising civil protection under martial law 1. Authorities and the public training

1. Authorities and the public training.

Organisation of alerting the territorial authorities and units of the SES under martial law. Interaction organisation of the SESU territorial units with military administrations, military command bodies, law enforcement agencies and other formations established in accordance with the legislation on evacuation measures is carried out in order to coordinate the activities of central and local executive authorities, local self-government bodies, military formations established in accordance with the laws and public associations on the organisation and evacuation and to identify ways and means of solving the problems of evacuation. Organisation of working, non-working population and students (inclusive education) protection, taking into account the experience of local authorities.

2. Sheltering people in protective structures

2.1. Providing shelters and organising population evacuation during the war.

3. Alerting and informing the population

3.1 A nationwide automated system for centralised wartime public warning. Participation of territorial bodies and subdivisions of the State Emergency Service in the implementation of public notification (transmission of urgent messages) about the threat or occurrence of emergencies, the threat of a missile-bomb strike. Organization of communications and operation of hotline 101 under martial law.

3.2. Informing the public using the broadcasting service of mobile operators.

Organization of informing the territorial bodies staff and units of the State Emergency Service, the population about the situation in the zone of possible damage.

4. Nuclear and chemical protection

4.1. Organising radiation and chemical detection and assessment at settlements where radiological or chemical weapons have been used. Ukrainian experience in relation to international standards.

Organization of operational actions in areas of permanent boost (in operation areas). Assessment of the radiation and chemical situation in populated areas in the event of the use of combat toxic substances. Peculiarities of carrying out work in case of use of radioactive substances. Peculiarities of interaction of emergency response units in case of chemical weapons use.

1.5 Peculiarities of fire fighting at electric power objects in times of war.

The situation after the shelling of energy facilities. Extinguishing fires at energy facilities after shelling. Algorithm of actions of the head of fire extinguishing after shelling of energy facilities. Features of ensuring the safety of personnel of fire and rescue units during firefighting at energy facilities.

2. Mine action activities in Ukraine under martial law

2.1 Analysis of the territory pollution in Ukraine with explosive objects because of hostilities. State Emergency Service of Ukraine pyrotechnic divisions development.
